Speaker bios:

Professor Zoë James

Dr Zoë James is Professor of Criminology. Zoë's key research interests lie in examining hate from a critical perspective with a particular focus on the harms of hate experienced by Gypsies, Travellers and Roma. Zoë's research has explored how mobility, accommodation, policing and planning have impacted the lived experience of Gypsies, Travellers and Roma. Zoë is Co-Director of the International Network for Hate Studies and has published and presented her work nationally and internationally, most recently authoring a monograph *The Harms of Hate against Gypsies and Travellers: A critical hate studies perspective*.

Dr Rachel Stuart

Rachel is a criminology lecturer and researcher based at Brunel University. Rachel's positionality as an academic of mixed Traveller and Gypsy heritage has seen her focus on research that considers the policing and criminalisation of Gypsy, Roma and Traveller communities through an interdisciplinary lens. Rachel acted as a consultant and researcher on a project funded by the National Institute for Health and Care Research, that investigated the uptake of COVID-19 preventative measures among Gypsy, Roma and Traveller communities. Rachel has helped reveal extreme levels of systemic violence experienced by the people taking part of the project, in terms of excessive policing and racism within the health care system and other public institutions.

Josie O'Driscoll

Josie is an Irish Traveller who has dedicated her career to advocating for the Gypsy, Roma, and Traveller people, combating discrimination, and promoting community ownership. Josie has taken on leadership roles in various governmental advisory and equality boards, and she founded and chaired GATE Herts, a not-for-profit charity led by Gypsy, Roma, and Traveller people. In her current role as Chief Officer, Josie continues to push for eliminating discrimination and disadvantage and her work with youth groups, mentees and partnership projects demonstrates her commitment to empowering and uplifting Gypsy, Roma, and Traveller people.

Stephen Walcott

Stephen is a Senior Researcher at the Runnymede Trust. Stephen has previously worked at the think tank Demos and at the Police Foundation where he built research expertise in race, policing and the criminal justice system. At Runnymede Stephen is currently leading on various research projects and contributing to policy work on economic injustice and health determinants.
